Lancaster High School Distinguished Alumni HALL OF FAME

PURPOSE:

Lancaster High School has established a long-standing tradition of academic and athletic excellence. Many graduates, who distinguished themselves in the classrooms and in athletic or scholastic competition, continued to distinguish themselves after graduation.

It is the purpose of the Distinguished Alumni HALL OF FAME to recognize such individuals who have, through their performance, conduct and achievement brought credit and honor to themselves and Lancaster High School. Their public example will hopefully serve to inspire future graduates to perform and serve in the same spirit.

ELIGIBILITY

To be eligible for selection and induction into the Distinguished Alumni HALL OF FAME, the person must meet the following qualifications.

1. The nominee must be a graduate of Lancaster High School. A period of five years must have elapsed between graduation and nomination for induction.
2. Candidates must be nominated on the official nominating form (see reverse side).
3. Candidates must have:
 - a. made a significant and recognized contribution to society or their profession, OR
 - b. been recognized for outstanding performance in the arts, athletics, government or public service, OR
 - c. advanced the cause of education science or medicine through practice and/or research, OR
 - d. been recognized for other outstanding achievement, accomplishment, contribution or act that has had a profound and positive effect.
4. Candidates may be nominated and inducted posthumously.
5. Any supporting material such as newspaper articles, stories, etc. must be submitted with the nominating form.

SELECTION:

A committee comprised of L.H.S. Alumni will review the nominations and select the persons to be honored each year. Persons selected for induction will be notified by the selection committee. Induction into the HALL OF FAME will take place during ceremonies to be scheduled at a convenient and appropriate time.

Each inductee will be honored with a portrait and plaque to be enshrined in the Distinguished Alumni HALL OF FAME at Lancaster High School.
